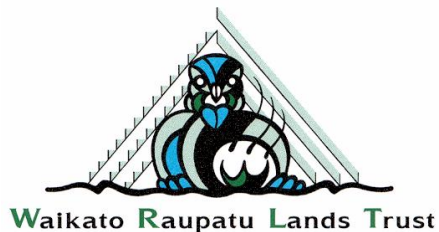

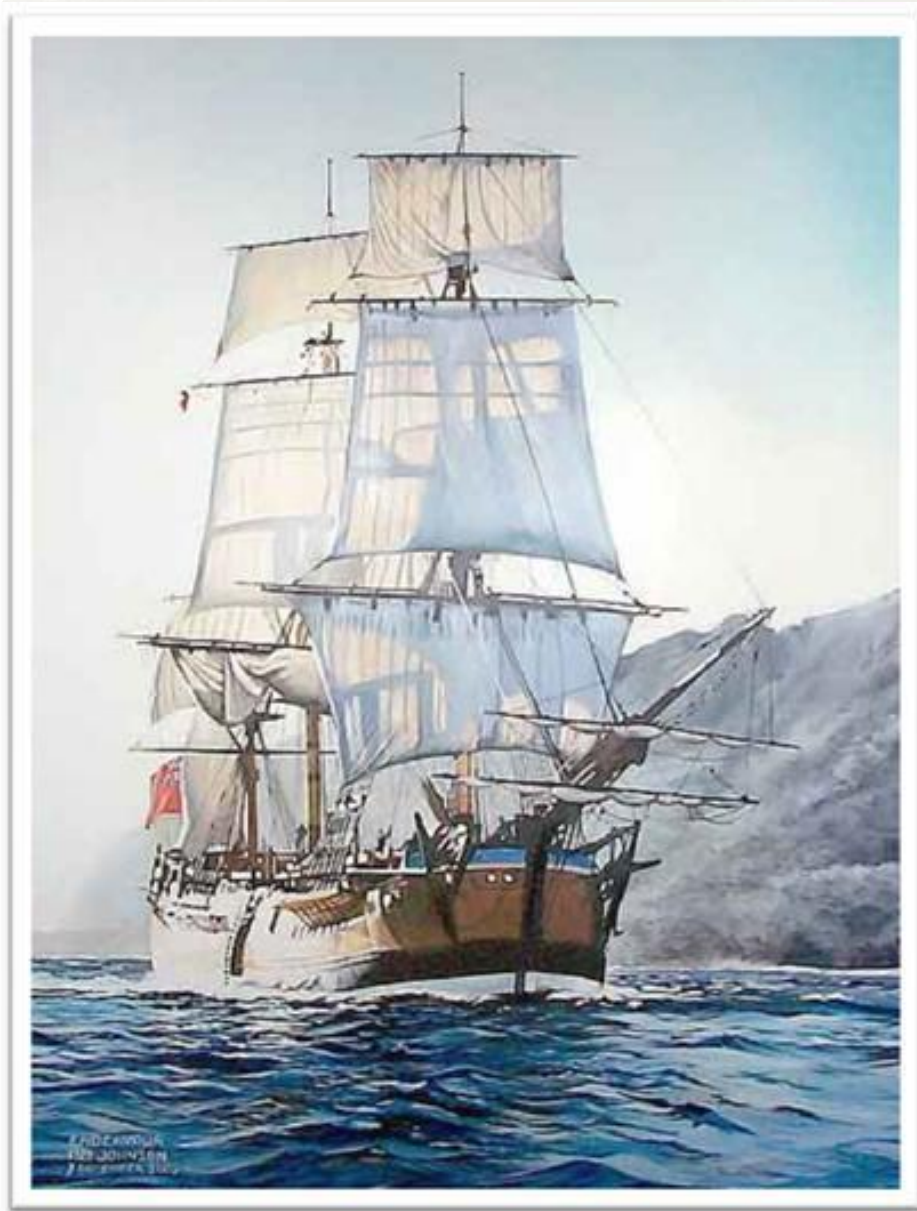

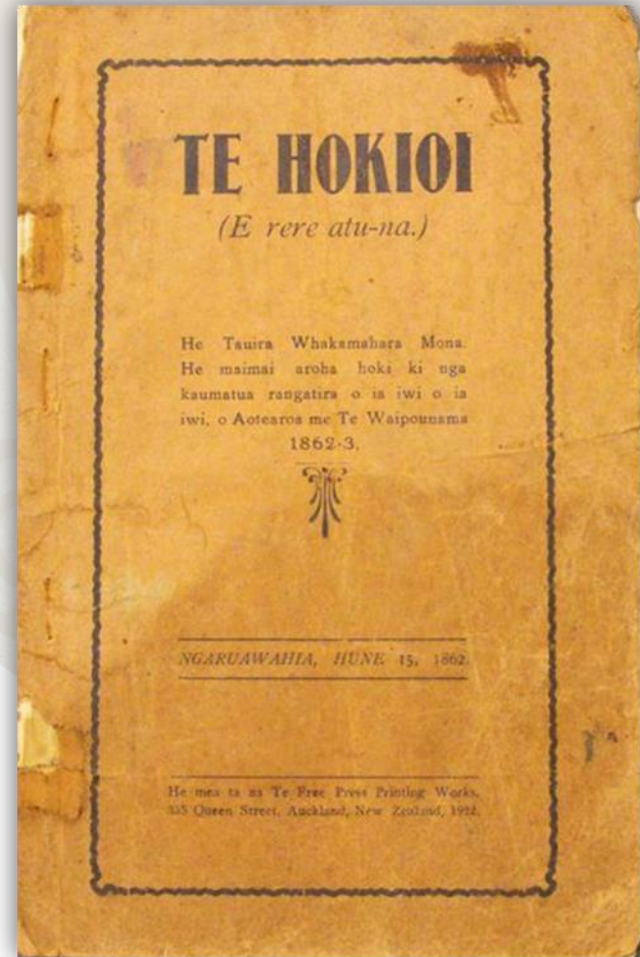

Protected and supplied the new settlement of Auckland

- 1849 Governor Grey requested Pootatau to provide military protection for the new settlement of Auckland against Nga Puhi attack.

Wherowhero*

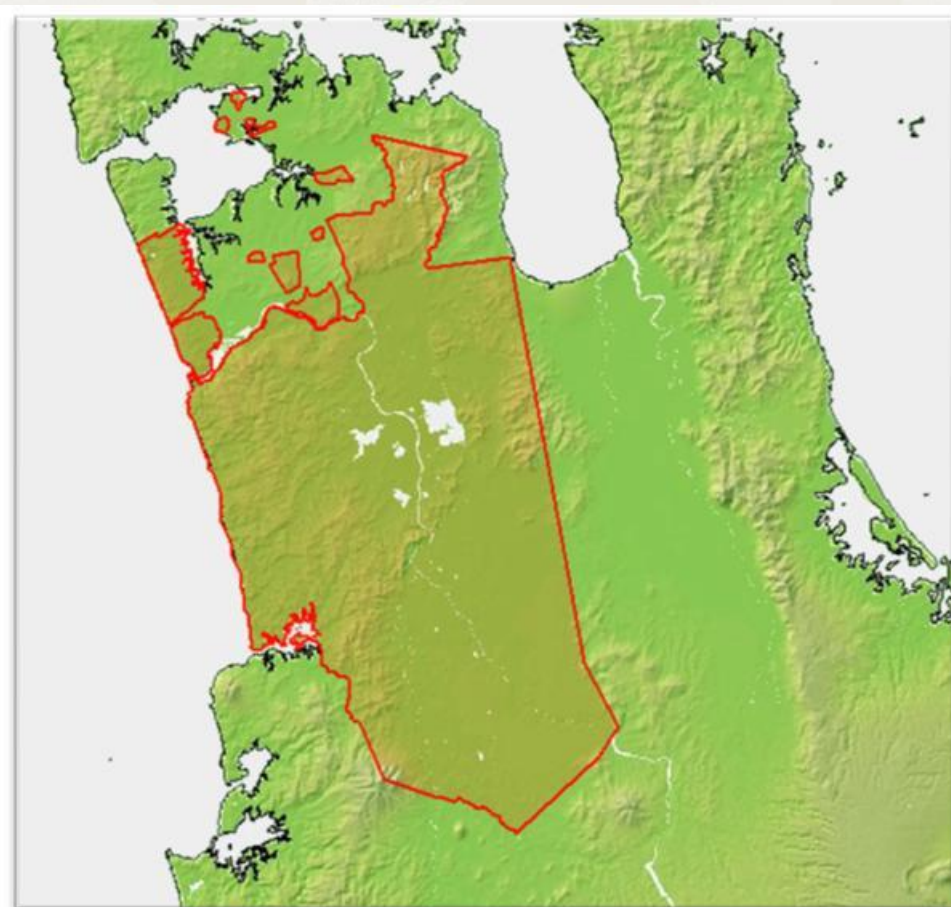

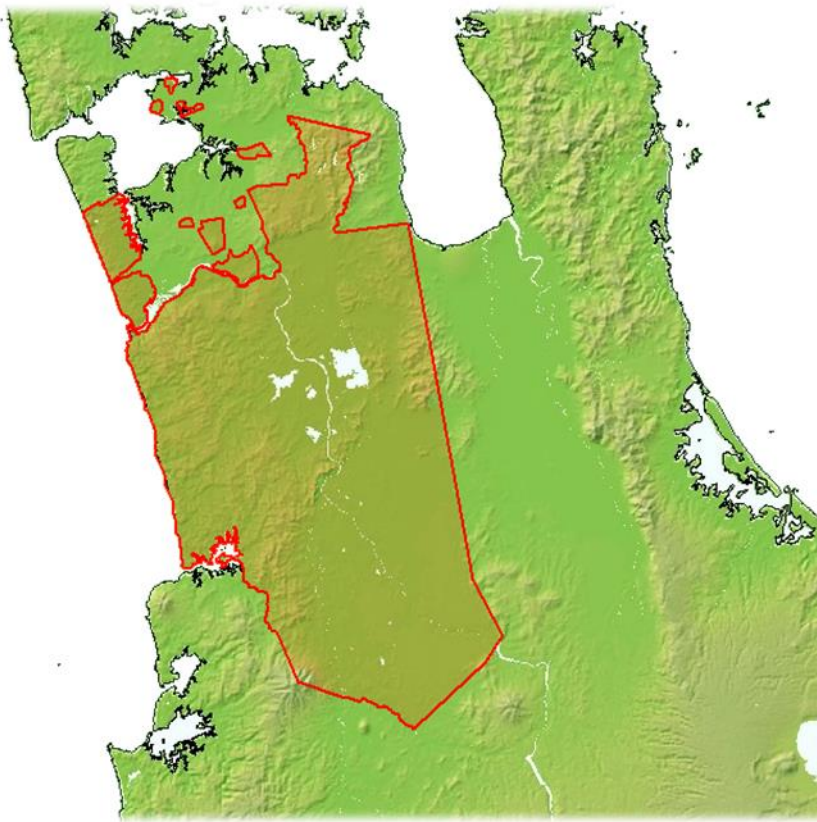
Kingitanga Movement:

1863 Crown response:

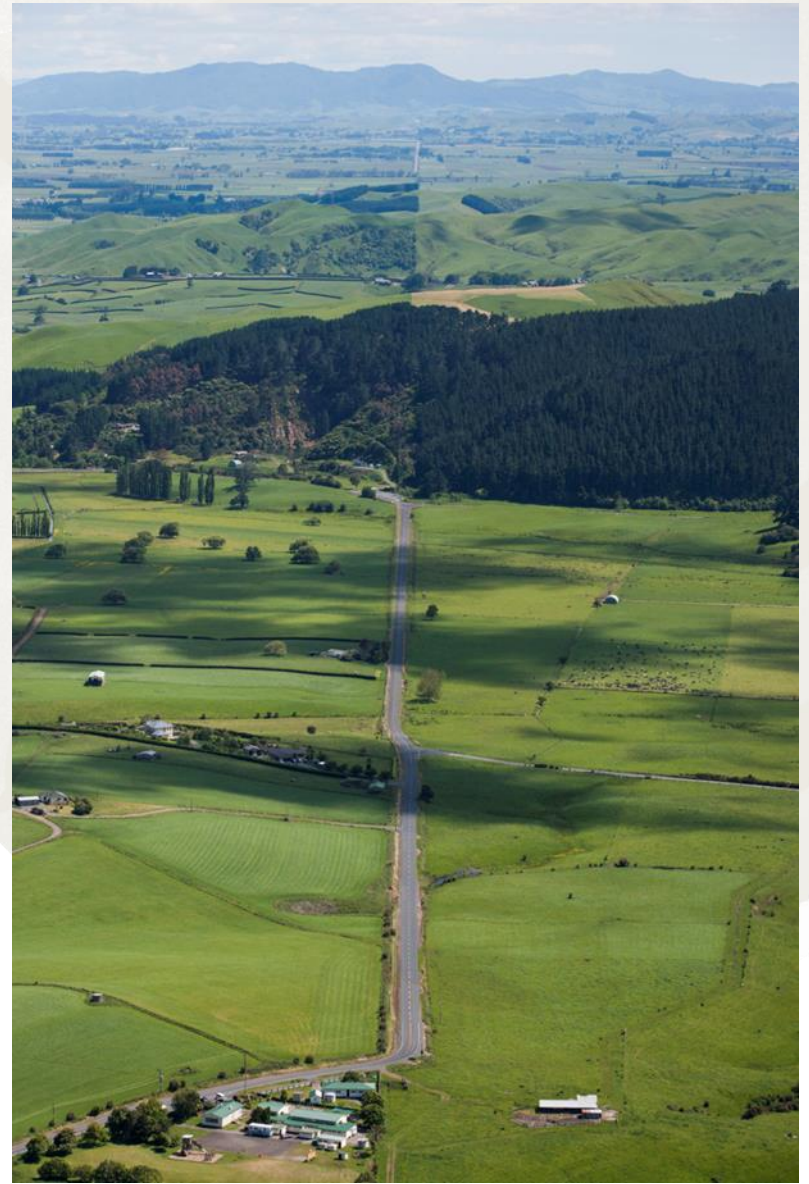
- Fabricated imminent invasion of Auckland by Waikato-Tainui
- NZ Settlements Act
- Invasion of Waikato
- Tribe driven into exile
- 1.2 million acres confiscated



1863 Confiscations



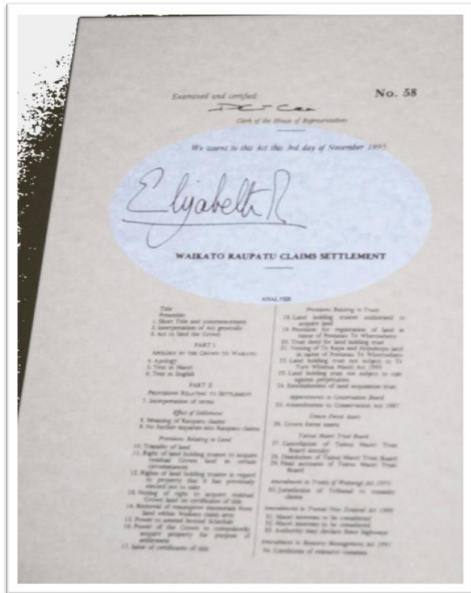
Land and natural resources including the river were confiscated...

Crown Apology:

Land confiscations were illegal and unjust, caused the loss of life and crippled the welfare of the people of Waikato-Tainui...

There on the fertile mound I would rest my head,
and look through the thighs of Taupiri.

There at the place of all creation...let the King come forth



Waikato-Tainui Environmental Plan

- Waikato-Tainui aspires to the restoration of the environment to the state that Kiingi Taawhiao observed when he composed his maimai aroha.
- Maimai aroha is the key driver and environmental indicator.
- Our Matauranga Maori

Key Priority – Towards Environmental Enhancement

- Waikato-Tainui is in favour of an approach to resource use and activity operation that sees a net benefit back to the environment in such a way that the environment is actually enhanced from the resource use, activity, or development.

Key Objective – Water Quality

- Water quality is such that fresh water within the rohe of Waikato-Tainui are fishable, swimmable and drinkable in all places (with water quality to the level that Kingi Tawhiao could have expected in his time 1860's).

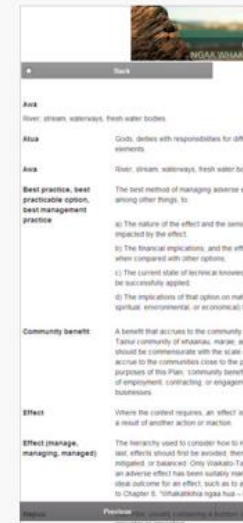
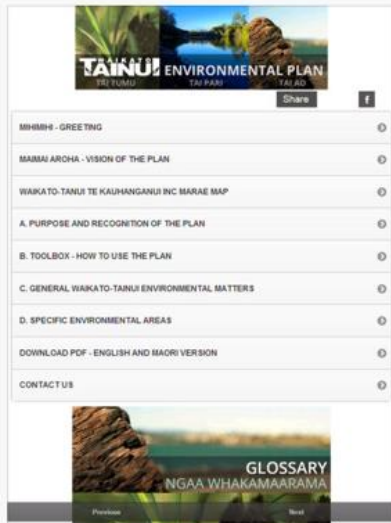

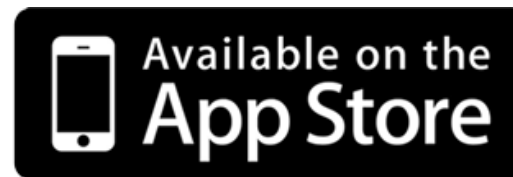
